Phil Huse, Global Head of Network and Commercial Strategy - Argenta Manufacturing

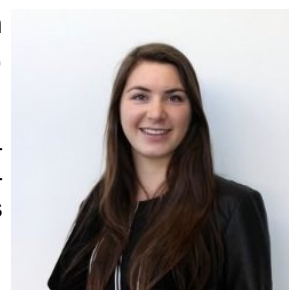
